- 1. The issuance priority list of Categories of Products was notified with the Bulletin (3/2018) dated on 26.7.2018 issued by the Ministry of Commerce for the Wholesale/Retail distribution carried out by the Foreign Companies and Joint Venture Companies.
- 2. With the view to fulfill the demand and market requirements while distributing in the local market, the allowed commodity groups are amended by adding with raw material for foodstuff, raw materials for animal, commodities for industrial use and industrial raw materials, spare parts for motor vehicles and heavy machinery and related goods as priority commodity groups.
- 3. Therefore, Priority List of Categories of Products for Wholesale/Retail distribution carried out by the Foreign Company, Joint Venture Company is announced as per attachment.

The Priority List of Categories of Products on Wholesale and Retail distribution for foreign companies and joint venture companies

- 1. Consumers Goods (Including of Clothing, Clock and Watch, Cosmetics Products)
- 2. Foodstuff including the following categories of commodities-
 - (a) Agricultural produce (except prohibited commodities for importing and selling due to the needs of the country;
 - (b) Marine Products;
 - (c) Animal Products;
 - (d) Instant Foods:
 - (e) Soft Drinks;
 - (f) locally produced beverages;
 - (g) raw material for foodstuffs.
- 3. Household goods (Ceramics, Pottery, Glass including glassware products)
- 4. Kitchenwares
- 5. Medicines and Medical Products, Hospital Equipments
- 6. Animal feed and Veterinary Medicine
- 7. Stationary
- 8. Furniture
- 9. Sports Goods
- 10. Communication Devices (including Camera and Phone)
- 11. Electronic goods
- 12. Construction material and equipment
- 13. Electrical Goods
- 14. Chemical for Industrial Use

- 15. Industrial use materials and industrial raw materials
- 16. Seeds, Agricultural Inputs and Products used for Agriculture
- 17. Agricultural Machinery and Equipment
- 18. Machines, Mechanical Appliances and Parts
- 19. Bicycles
- 20. Motorcycle, Accessories and Parts
- 21. Automobile Parts, and Parts of Machinery and their accessories
- 22. Toys
- 23. Home decoration products and accessories (including flowers and plants)
- 24. Souvenir and Handicrafts Products
- 25. Art materials, musical instruments and Accessories (excluding Antiques)

Remark:

- 1. When selling the listed items under a retail/wholesale registration certificate, they must prioritize local products to sell by adding values to the products.
- 2. When importing goods from abroad, companies shall comply with the laws, regulations, procedures and rules of relevant Ministries as may be applicable to the goods.
- 3. The Priority List of products groups may be amended as necessary.
